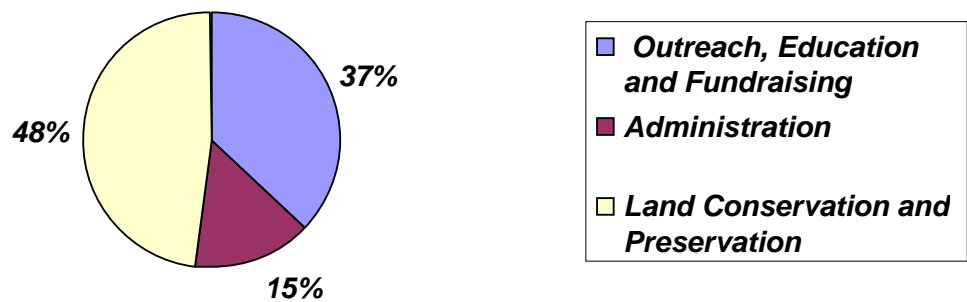
Conservation Matters.....

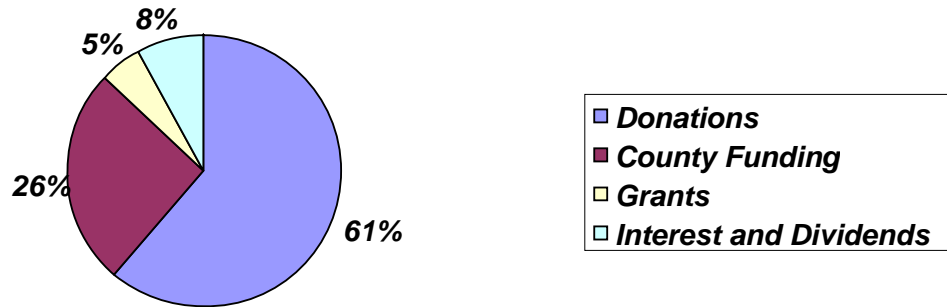
2009 Operating Expenses
