

2012 Annual Report

Committed to Conservation with a Focus on Partnerships, Habitat Protection and Enhancement of our Local Food Economy

2012 marked our 19th year protecting land in Orange County, and during this time Orange County Land Trust edged even closer to protecting a total of nearly 5,000 acres of land. Two decades earlier, this milestone seemed a long way off to the newly formed land trust, led by former County Executive Louis V. Mills.

Today, whether helping acquire lands that comprise some of our most diverse habitats in the county, drafting easements that help agriculture remain a large part of our economic base, or partnering with other conservation organizations to ensure important lands remain open and accessible, Orange County Land Trust is getting the job of land protection done in Orange County. Whereas 20 years ago, development pressure was the main impetus for protecting land, today land protection also takes into account the scenic, agricultural and historic value of our land, the health of our communities and the science behind the identification of key parcels in need of protection. The ability for wildlife to traverse the landscape in order to provide for genetic variation in the face of climate change is an important aspect to our land protection efforts. Advocating for farmland protection funding so that farmers can continue to provide fresh local foods, as well as ensuring that there are places for outdoor recreation, rejuvenation and nature study, are also important aspects to our land protection efforts.

With these new philosophies to land protection in mind, Orange County Land Trust helped protect nearly 840 acres of land in 2012. July saw the closing of 435 acres of land along the Shawangunk Ridge in Greenville, working in partnership with Open Space Institute and NYNJ Trail Conference. These protected lands added to a proposed 50 mile trail corridor of connected open space, creating linkages for recreation and wildlife habitat and stretching from Kingston, NY to High Point, NJ. Orange County Land Trust manages these lands until their future proposed transfer to New York State.


In 2012, Orange County Land Trust also worked with Open Space Institute and the Town of Warwick in protecting two farms totaling nearly 220 acres in the Town of Warwick.

Then, in December of 2012, Orange County Land Trust received 187-acres of land in the towns of Chester and Blooming Grove, part of a \$1.3 million donation and bargain sale. The land, now known as the Jack and Louise Birnberg Preserve, lies within the Moodna Creek watershed and is comprised of wetlands, meadows and woodlands. It is located adjacent to and accessible by, the county's rail trail. A trail system is planned that will highlight the biodiversity of this protected wildlife preserve, and its unique flora and fauna, including a newly discovered frog species.

Also in 2012, Orange County Land Trust continued to advocate for the restoration of NYS's Environmental Protection Fund to aid farmland protection, worked to maintain and improve public access to our nature preserves totaling 1,106 acres, as well as stewarded the conservation easements held on nearly 3,400 acres of private land. The Land Trust also continued work to develop landscape scale land conservation efforts in Cornwall, Mountainville and Salisbury Mills in collaboration with Open Space Institute, Palisades Interstate Parks Commission, NYS Department of Environmental Conservation, the United States Military Academy at West Point, Storm King Art Center, Black Rock Forest Consortium and Hudson Highlands Land Trust. These efforts will protect hundreds of acres of land that will enhance long-term ecological connectivity in southern NYS and ensure a quality buffer wildlife habitat.

As we look ahead to the next 20 years of conservation, Orange County Land Trust will continue to work to preserve our treasured natural resources, sustain our local agricultural economies, and maximize philanthropic investments from the community. With support from our individual donors, county and state governments and conservation partners, we will continue to work to save the lands that are important to the communities we serve.


2012 Income and Expenses



In 2012, donations from the community totaled \$334,298, accounting for 65% of the land trust's income. County funding of \$82,000 accounted for 16% of income and \$62,377 in grants accounted for

12% of land trust income. Interest income from the land trust's three endowment funds accounted for \$35,379, or 7% of income.

In addition, the land trust received an in-kind donation of land valued at \$1.3 million. Total assets in 2012, including investments and land, were valued at \$3,978,923. The value of land in 2012 was \$3,080,605.



In 2012, nearly 58% of income was allocated to land protection and conservation, for a total of \$255,254.55. About 22% of income was allocated to management and support, for a total of \$93,990.00. In the area of development, \$88,306.45, or 20% of income was allocated to provide these services.
